IT IS IMPORTANT THAT YOU ARE AS ACCURATE AS POSSIBLE. THIS IS THE SCHEDULE THAT YOU WILL BE MONETARILY RESPONSIBLE FOR.

1. There is a minimum of two (2) days per week for three weeks for the summer session. If your child (ren) will be attending less than three weeks, the charge will be the daily rate plus 20%.
2. Program changes prior to the start of camp are subject to availability and must be submitted in writing to the office.
3. These rates include all trips and transportation unless noted that a specific trip will be additional due to higher costs for that trip
4. **The two-week notification of termination requirement as stated on the registration forms for year-round children, does not apply to the summer session.**
5. The sibling discount is 5% off the flat rate for each sibling.
6. Payment schedule
 - * Pre-payment of \$400.00 per child is due by **Friday, February 2, 2024.**
 - * First payment of ½ of the enrollment fee is due by **Friday, April 5, 2024**
 - * Second payment of the remaining ½ of the enrollment fee is due by **Friday, June 14, 2024** (This is minus the pre-payment fee of \$400.00)
 - * All fees, including tuition, registration fees (if applicable), and extra trips must be prepaid before the first day of camp as stated on the enrollment form or it will delay the start of camp for your child, NO EXCEPTIONS!

UNDER NO CIRCUMSTANCES ARE THESE PAYMENTS REFUNDABLE
7. Payment method – We accept cash, checks, Zelle and credit cards (a convenience fee of 3½% will be applied for credit card use)
8. Registration Fees – For **NEW** students the registration fee is \$100.00, which is utilized as a registration fee only. For additional siblings applying at the same time, there will be a \$25.00 registration charge.
UNDER NO CIRCUMSTANCES ARE THESE FEES REFUNDABLE.
9. Pre-payment Fees – For all children in Kindergarten through 8th grade a pre-payment fee of \$400.00 is due by **Friday February 2, 2024.** This fee will be applied to your last summer payment.
UNDER NO CIRCUMSTANCES ARE THESE FEES REFUNDABLE.
10. Vacation and Sick Days – **Any vacation days/weeks must be blocked out by April 5, 2024. After this date there will be NO more changes allowed to your child’s summer schedule. You will be responsible for and charged for all scheduled days and weeks you have reserved. THERE ARE NO SICK/VACATION DAYS DURING THE SUMMER SESSION. You will be charged for the time absent during your reserved weeks/days.**
11. Any payment not received on time, according to the payment schedule above, will be subject to a \$25 per week per child late fee.
