Enrollment & Scheduling	<ul style="list-style-type: none"> A minimum attendance of 2 days/week for at least 3 weeks is required for the summer session. If attending for less than three weeks, tuition is the daily rate + 20%. Any program changes before camp begins must be submitted in writing and are based on availability. Weekly rates include all weekly trips: i.e., pool, bowling, and transportation. The year-round 2-week termination policy does NOT apply to summer camp.
Vacation & Absences	<ul style="list-style-type: none"> Vacation weeks/days must be submitted by Friday, April 3, 2026. After this deadline, no schedule changes will be accepted. Families are financially responsible for all reserved weeks/days, regardless of attendance. No sick days or vacation days are credited during the summer session.
Registration Fees	<ul style="list-style-type: none"> NEW students: \$100.00 registration fee. Additional siblings registered at the same time: \$25.00 each. All registration fees are NON-REFUNDABLE.
Payment Requirements & Methods	<ul style="list-style-type: none"> Sibling discount: 5% off the flat rate for each sibling. All tuition, fees, trips, swim lessons, and food charges must be paid in full before the first day of camp — NO EXCEPTIONS. Any payment not received on time will incur a \$25 per week per child late fee. Accepted payment methods: credit cards (3.5% fee), cash, Zelle, and checks. All payments are NON-REFUNDABLE.
